Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of David Christopherson, Stacy Ingram, and any duly appointed Corporate Secretary of Floor & Decor Holdings, Inc. (the "<u>Company</u>"), with full power of substitution and resubstitution, acting individually, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
